

RESOLUTION: POL II/B
COUNCIL: Council on Political Affairs
TOPIC: Formulating ways to increase societal inclusion and political involvement amongst individuals who may be susceptible to insurgent group recruitment.

Concerned about the prevalence of extremist movements, violent ideologies, and militant groups,

Alarmed at rate of recruitment of vulnerable communities, particularly among Arab youth, within the borders of members states,

Recognizing that one of the best solutions to terror is to address the root causes before they manifest in larger capacities and threaten state security,

Acknowledging education is a very successful solution to terror that also creates stronger citizens, and

Valuing effective strategies to erode intellectual support for corrupted, extremist ideologies online,

Be it hereby resolved that the League of Arab States:

1. **Establishes** a League-wide Online Anti-Insurgent Campaign (OAIC) with the intention to,
 - a. Coordinate and enhance the league-wide effort to collect, identify, and analyze the means insurgent groups use to recruit through multimedia platforms,
 - b. Identify individuals who are deemed as susceptible to recruitment from insurgent military groups,
 - c. Dialogue in online chat rooms and forums where insurgent groups are known to recruit in the effort to dispel radical ideologies,
 - d. To counter extremist arguments in online forums and amplify credible voices, and
 - e. To voluntarily share information with specific member-states based on the needs and willingness of the host state;
2. **Constructs** the organs of the OAIC as follows,
 - a. An Advisory Council that is tasked with compiling a confidential monthly document of materials that are reviewed and analyzed by OAIC workers and presenting that information to the League,

- i. Composed of representatives, one elected from each sponsor and signatory of the resolution,
 - ii. Encourages two to four year terms for those serving on the advisory council, and any member of the Arab League can have a seat on the council at any time,
 - iii. Recognizes the charter of the League, and therefore if any selected country does not wish to serve on the Advisory board, they may chose to pass on their seat in the board, and
 - iv. Realizing the need for a full board, if a selected country chooses to not serve its term on the board, the OAIC will redraw a different member state to serve in its place,
 - b. An Action Team that is tasked with the execution of the mission statement of the OAIC, wherein,
 - i. The OAIC Action Team will be selected by members of the advisory council for their knowledge of,
 - 1. How insurgent groups recruit online,
 - 2. Insurgent propaganda,
 - 3. Where insurgent groups sent online, and
 - 4. Methods to prevent recruitment, and
 - ii. The OAIC action team will herein use the aforementioned knowledge in order to achieve its mission statement of preventing recruitment of insurgent groups;
- 3. **Establishes** a rotating head office for the OAIC that will,
 - a. Rotate every four years to different metropolitan cities within the League,
 - b. Be selected through a bid made at the beginning of every four year period where the city will be judged based on ability to house the OAIC headquarters,
 - c. OAIC headquarters will serve as a headquarters for,
 - i. Information technology professionals,
 - ii. Housing the chambers of the OJAC advisor board,
 - iii. Senior ulama that serve as OAIC workers from across member states,
 - iv. The OJAC action team,
 - v. Administrative personnel,
 - vi. Maintenance staff, and
 - vii. Any other personnel and workers deemed necessary for the functioning of the OAIC's mission and tasks;
- 4. **Urges** the OAIC to prepare funding and infrastructure to provide education to regions with a propensity for insurgent group recruitment,
 - a. Leaves the possibility for further expansion of the OAIC, and

- b. During the year 2025, the OAIC will release a confidential report highlighting its accomplishments and capacity for growth into the role of educator.
